- Complete, accurate instructions must accompany your file. We are not responsible for misunderstandings or delays caused by missing or incomplete information.
- We prefer high resolution pdf files, with fonts embedded, for imaging film, plates or proofs. We support native files created in Adobe formats (InDesign, Illustrator, Photoshop). If you submit native files, please include all supporting files, graphics and fonts. We cannot accept native files in Microsoft Word, Excel, Publisher or PowerPoint – please send high resolution pdfs for these programs.
- **Published prices are based on standard turnaround time.** Normally that means a 24-hour turn. As a general rule we do not charge rush fees if we can accommodate your deadline. We are closed on major holidays and weekends, but we are willing to work with you if you have a deadline – please call to find out if someone will be available to help. *Service on weekends, holidays and after hours may incur overtime charges.* If you have concerns, please give us a call and let us know what you need.
- **Payment is due at time of service unless credit terms have been established.** We accept credit cards. If you choose to pay by card, a credit card fee will be added to your invoice amount (currently 3.75% + 50¢). **All new customers will be invoiced C.O.D.** and a QuickBooks invoice with payment options will be sent. On established accounts, payment is **due 30 days** from the **invoice date**. Reminder statements are sent around the 3rd of each month.
- Every attempt is made to make sure your files are correctly imaged. If Delta Graphics has made an error, we are responsible only for the cost of material replacement of film, plates or proofs. You should carefully inspect all materials when they are received and notify us within five working days if there is a problem with the output. You are responsible for proofreading files typeset by Delta Graphics, including, but not limited to: addresses, phone numbers, spelling, and color breaks. By approving artwork you are accepting responsibility for any errors contained within. We are never responsible for printing costs or other losses incurred by incorrect or faulty materials, regardless of error.
